## REGIONAL ENERGY EFFICIENCY PROGRAM

- Advocacy till 2017 for the development of an ambitious and effective program to save public budget and energy resources.
- Approval of the new regional program of the Rivne region in the field of EE and RES on March 16, 2018 by the decision of the Rivne Oblast Council № 866 "On the Integrated Energy Efficiency Program of Rivne Oblast for the period 2018-2025".
- Development of proposals for improvement of the regional energy efficiency program and their presentation at the meeting of the regional council commission. Development of strategic targets and indicators for the development of the energy sector of the region by 2023, as well as mechanisms that would stimulate the development of renewable energy sources and energy efficiency.




## REGIONAL COMPETITION OF ENERGY EFFICIENCY PROJECTS

- Thanks to the participation of the Ecoclub, according to officials, it was possible to save millions of hryvnias of budget funds.

## ANALYSIS OF ENERGY PLANS OF THE CITY (SEAPS)

- Developed a methodology for analyzing energy plans.
- 3 webinars for interested people were conducted.
- An analysis of the energy plan of Rivne.
- Assistance with SEAP analysis of Poltava, Kremenchuk, Khmelnytsky, Ivano-Frankivsk, Chortkiv.
- Energy plan of Uzhgorod was developed.





## Energy City Plans Should Reduce Emissions and Lead to Economic Growth

"Analyzing the SEAPs of Ukrainian cities, the Ecoclub wanted to make sure that they really lead to emission reductions and sustainable urban development. Now we see that not all cities have plans that are equally effective and want to understand how to correct the situation and improve them. We already have an appeal from the interested partners in Armenia and Georgia, so we want to analyze the plans of other cities of Eastern Europe according to the same methodology."

## TRAINING FOR CONDOMINIUMS AND BUDGETS

- Lectures for the Rivne condominiums "The potential of house saving: thermal and energy surveys" and "How to properly prepare housing for the heating season"
- Lectures at the Zhytomyr City Council "Energy efficient housing" and "Energy Efficiency in Budgetary Institutions"



## REVOLVING FUNDS

- According to the results of the information tour, 3 revolving funds were created: in Lublinets, Klevans'kyi amalgamated territorial community, smt. Shchastia
- Daily energy monitoring was introduced in the Bahmut amalgamated territorial community
- Installation of solar collectors at a kindergarten



## ENERGY COOPERATIVE

- Polls about the availability of resources for energy production
- Selection of 2 communities for the creation of a cooperative: Karashynska and Berezdivska amalgamated territorial community
- Development of business plans for these communities
- Development of the charter and registration of Berezdivsky Energy Cooperative. Ecoclub is a co-founder.
- Participation in work on the developing of a law on cooperatives



## ANALYSIS OF THE POTENTIAL IN THE RENEWABLE ENERGY RESOURCES OF KHMELNYTSK OBLAST

- A methodology for analyzing the potential of renewable energy sources has been developed
- An analysis of the Khmelnytsk Oblast's potential was carried out, the results of which will be included in the new strategy of regional development
- Participation of stakeholders (public, government, business, scientists, media) in the process of implementation of the project on the platform of the Khmelnitsky energy cluster
- Forum Khmelnytsky Energy Independence is our common cause, which will be attended by more than 100 participants (power, business, scientists, media, public).

## PARTICIPATION IN CLIMATE NEGOTIATIONS

During the week, the activists took part in events, sought partners to support the energy transition of Ukraine, and followed the participation of the Ukrainian delegation in the talks.

## WORKSHOP "TAKING ACCOUNT OF CLIMATE CHANGES IN GROWTH DEVELOPMENT"

Joint work the Ministry for Environmental Protection, the Ukrainian Climate Network and representatives of local communities on what measures and actions should be implemented in order to effectively implement climate policies on the ground.

Participants learned to develop local climate policy, get acquainted with best foreign examples, sought incentives for local authorities and communities to integrate climate policy into local development strategies

# INFORMATIONAL CAMPAIGN "SAVE USTIA RIVER!"



## PETITION

Activists of the Ecoclub collected and marked on the map more than 12 discharges, which caused the river impurities.

Participation in meetings with the mayor, representatives of the KP, and deputies of the city council.



## NIGHT RACE

Together with the Rivne Running Club in Rivne, race was organized for the Youth Day "The river has to live!".

Over 100 participants overcame 3 km to attract attention of the Rivne community to the polluted Ustia river.



## STREET PERFORMANCES

Printing and distribution of leaflets with the requirements in order to protect the river Ustia.

5 street events with over 700 visitors.




## INCOME



